The difficult decision to cancel the Murray River Adventurers Cruise for next March has been met with excitement and expectation with the replacement being a road trip of the Yorke Peninsular by Caravan, Tent, Camper, Cabin, Motel, or B&B instead of the boats. Mind you if you wish you can happily camp with your boat. Dates are not set in concrete as the trip is in the planning stage but if you can keep free the period Monday 6th March to Monday 27th March that will leave us plenty of time to see all without a huge rush. Stay tuned for further information as the plan develops. It is important to get the planning underway so we can prebook the caravan parks etc.

After our recent AGM our incoming committee met on November 15th and had some quite important discussions about the direction and policies of the club. We need to communicate these to you and have produced this newsletter in response. Some of these discussions will be on-going and our committee will be keen for any feedback from members about the issues of safety on the water, the reinstatement of sailing burgees and requirement for third party boat insurance.

That is all from me. Looking forward to seeing you all on the water at the next cruise with what seems to be now becoming an annual "Beat the Blues"!

THIRD PARTY BOAT INSURANCE

It is BTYC club policy that all members insure their boats for third party insurance as a minimum insurance cover. However while this might seem a simple policy statement, it has a number of complexities.

Some of our members sail custom built vessels and obtaining insurance for them can be very tricky, often requiring a full marine survey. A number of insurance companies will decline to insure boats that have not been built by a registered marine builder. Some insurers also decline to handle the insurance for boats of more than a certain age, regardless of their condition.

New Wave Marine Boat Insurance specialise in marine insurance for older boats. No need for a survey. This may be the answer for our members who have difficulty in obtaining insurance cover. Verbally the quote to insure a recently restored Boomerang 20 was around \$300.

If one of our boats is uninsured and has an accident with another boat that is within our club or a boat outside of the club during a club event, their insurance company will consider our club responsible and may sue our club. Our club only has minimal assets and so there is not likely to be much joy for the litigant, but if legal action was commenced it would probably be the end of the club.

Several of our members have also expressed their desire to know and be confident that all club members carry third party insurance. Collisions are rare, but they do occasionally happen and having insurance negates some of the anxiety that can arise from such an event.

It has been revealing that some of the marinas that we have recently booked into as a club group have not asked for validation of insurance. Upon further inquiry, the marina office has simply told us that because we are a club they assume that all club members' boats are insured and therefore they don't need to see the insurance certificate.

Our treasurer has recently written to all members and asked for details of each vessels marine insurance

policy so that this can be entered into a registry. There is concern from the committee that some members may have trouble complying with this request. The policy is not intended to be difficult for any member, and if you are having trouble complying, please contact any of the committee members and seek some assistance.

FUTURE USE OF CLUB BURGEES TO BE REVIEWED

After a brief discussion at the Annual General Meeting in October 2022 it was resolved the club should only award burgees in the future for sailing participation milestones of up to a maximum of 10 cruises. The more substantial milestones of 15 club sails, 30 club sails, 50 club sails and 100 club sails (at least 3 members have achieved this last milsetone) were proposed be disbanded.

This decision has not been fully embraced by the membership. The premise of this decision was that records of club sailing participation during the past 2 to 3 years were not complete and we had lost count of members' sailing participation. There was also a view that the practice was a little antiquated.

Our club does not conduct racing events. The practice of awarding burgees is one way of recognising member's individual achievements and celebrating them.

The organisation and implementation of club cruises during the years of the Covid 19 pandemic has been difficult and somewhat disjointed. Fortunately our club newsletters contain a good record of club cruising history including the names of the participants on such cruises. A more accurate sailing data base has been created by Tony Pitt with David Morrissey's help and this will be adopted as the baseline for tallies of member's sailing achievements. The committee has decided that the compilation of sailing tallies will be continued and that the issue of awarding burgees for milestones in sailing tallies shall be reviewed at the next general meeting.

Welcome to two new members.

The Phosphorescence Party From the Voyages of Sprout, 2020

swing with about 60 dolphins in attendance. The other 2 crew members were asleep at the time.

SAFETY AT SEA BTYC Policy Discussion

There has been an on-going discussion at the BTYC committee for some time as to whether the club should have a separate safety policy. Mandatory marine safety requirements are always in force whenever a boat is on the water and this includes carrying life jackets, marine flares, emergency baling equipment and a number of other provisions. The discussion has been as to whether we need to add to these requirements.

The club already has a marine radio policy (VHF on each vessel) and encourages all boat skippers to undertake man-overboard drill when the seas are calm. One often discussed issue is at what stage during a cruise should the skipper of the vessel ensure that all crew put on their life jackets? One school of thought is that if the sail is reefed, then life jackets should be worn. But some of our members reef the sails for comfort reasons rather than any concern for safety, so is this then an appropriate policy?

Another issue is whether all boats should have a mandatory printed man-overboard procedure on board. In an emergency, such as a person in the water, panic can set in quickly. Having a printed and accessible procedure may be one way of avoiding mistakes and keeping calm when the unpredictable happens.

The debate is likely to continue. Our commodore and committee would welcome your ideas.

APOLLO BAY GETAWAY DEFERRED

Because of the decision to cancel the 2023 Murray River cruise and use the March window for a road trip to the Yorke Peninsula, it has also been decided not to proceed with the Apollo Bay Getaway this year. The two road trips would have been close together and the decision was made to just proceed with the one event.

The Apollo Bay Getaway will happen at a later date.
